### 1. OPENING ITEMS

## 2. APROVAL OF AGENDA

Jane moved to approve the agenda with additions, Barbara seconded the motion. Agenda was approved with additions.

## **5. DISCUSSION AND ACTION ITEMS**

# **5.1 President's Circle Strategic Plan- Elena Moiseeva and Eddie Hernandez**

Elena Moiseeva shared the presentation with the committee, showing how to revamp the President's Circle membership. (Presentation attached).

Committee asked questions about what a "courtesy member" is. Elena explained that some donors get a courtesy membership for large donations, at the discretion of the Executive Director. Committee asked the status of reaching out to President's Circle Lifetime Members. Staff explained that a letter has been drafted and will go out to all lifetime members asking for donations. The current Academic Angels newsletter will now become a combined "membership" newsletter, incorporating both membership groups. Rob suggested setting up an ongoing ad hoc committee to work with staff on member benefits. President's Circle Committee will meet for 3 planning sessions per year, with wine and appetizer, and spouses are welcome. Staff would plan these casual events. Advancement and Stewardship committee will oversee the President's Circle and meet regularly. President's Circle will not be governed by the Brown Act.

## 5.2 Newsletter

Newsletter will be combined for the Academic Angels and President's Circle. Committee was asked for naming suggestions for the newly combined newsletter.

# 5.3 Invisible Valley, Mary Pohlad Film

Tom Minder spoke to Mary Pohlad regarding doing an event next Fall with the film as the focus. Mary communicated that November was a good month and Tom suggested the second week of November at the Cultural Center in Palm Springs, with students encouraged to attend and possibly be transported by bus to the event. Jane Saltonstall shared that her and Rob Moon spoke to Michael Green and have an appointment on January 23 to tour the Cultural Center. Next step is to set up a meeting with Mary on how the event will proceed. Mary said she will be happy to help. Tom suggested they meet at Tom's home with Jane, Rob and Mary. Tom to get Mary's availability.

## 5.4 Pizza and Putters

Rob updated the committee on the March 3 event. Rob would like to appoint an ad hoc to continue planning with staff. Pizza vendor and venue contracts are being worked on. Pierro's Pizza will do the catering. Budget is \$8500 for the event Committee felt they could do the event under budget. An ad hoc committee will be formed with Shari Stewart and Paul Hinkes along with staff, to complete the details for the event. Do a "Save the Date" for Pizza and Putters, to be sent out via email as soon as possible.

# 5.5 Membership Renewals

Staff has sent out letters for President's Circle renewal. Elena shared that there are 47 lifetime members and they will be sent letters to consider donating. 46 members have renewed, of which 11 are either new, or rejoined after some break in membership. 18 faculty/staff joined the PC. 25 members pending renewal, and they have all been approached and encouraged to renew. Year 2000 - 2022 members will be contacted next to renew their membership. 60+ members have not renewed and will be sent letters and get phone calls.
