Diane Rubin welcomed Rubin Perez to the Board.

Rubin Perez introduced himself as a Trustee of the College of the Desert representing Area 1, consisting of Indio and portions of the eastern Coachella Valley.

He spoke briefly about the textbook rental program and the Roadrunner Express shuttle service, both of which he said President Hope would discuss in more detail in her report.

He announced the sale this week of New Markets Tax Credits for the Indio Child Development Center and the expansion of the Indio campus.

He shared the appointment of two new representatives to the Citizen Bond Oversight Committee: David Ready and Bruce Bauer both from Palm Springs.

#### 6.02 Superintendent's/President's Report

Laura Hope, Interim Superintendent/President

President Hope announced two new programs that will launch this semester: the \$5 textbook rental program and the new Roadrunner Express shuttle service. She thanked the Foundation, Friends of the Library, and private donors who made these programs possible.

#### 6.03 Bond Update

Diane Rubin, Board Chair and member of Citizen Bond Oversight Committee

Diane gave an update on the CC bonds. This issuance is now available for purchase, and it is expected that it will sell out. Marge Dodge pointed out that these are tax-free municipal bonds, and that the sale has been opened to all residents of the Coachella Valley first before being opened up to the big investors.

#### 6.04 Board Chair's Report

Diane Rubin, Board Chair

Diane Rubin welcomed all to the new Child Development Center. She introduced Dotty Durney, the new Executive Assistant in the Foundation office and welcomed Trustee Ruben Perez to the Board. She thanked all the committee members for their diligence,

enthusiasm hard work - they have been very busy this past month.

#### 6.05 Executive Director's Report

Catherine Abbott, Executive Director, College of the Desert Foundation

Catherine Abbott shared her gratitude that her team now complete with the addition of Eddie Hernandez and Elena Moiseeva. Preparations are well underway for State of the College. She asked Kirstien Renna to report on the current revenue and expenses for the event.

Bighorn Charities has awarded a \$10,000 grant to the Foundation to be used for the Central Pantry.

Gailya Brown is working with the Schlinger Chrisman Foundation for a grant to purchase iPads for the Nursing program.

She asked Norma Castaneda to give an update on Stepping Out. We made an offer country singer, Clay Walker, and we expect to hear back from him by Friday.

A bench dedication and celebration of life will be held on Feb 8, 3:00-4:30pm in honor of the late COD professor, Lisa Wilander, who was instrumental in our disabled students program services (DSPS). Everyone is invited to join us just outside the Cravens Student Center.

#### 6.06 Director of Development's Report

Eddie Hernandez, Director of Development, College of the Desert Foundation

Eddie gave report on State of the College event taking place on Thursday Feb. 29 at Toyota of the Desert 5-7pm. He acknowledged all of the sponsors, especially Toyota of the Desert who is not only providing the venue to us at no cost, but they also made a \$5000 donation.

He shared that campus tours have been very successful. As a result of these tours, Gerald Fogelson set up a \$25,000 scholarship. Tours for the second half will be on Feb 8, Feb 15, and Feb 25. Follow-up calls are made to the tour guests to encourage membership in the Academic Angels or President's Circle. The Development team is also working to create thank-you videos from the students to the donors. He invited all members to sign up for a campus tour.

The Development team is creating a new membership, the President's Business Circle, to connect with the business community. He met with an anonymous donor last week who asked to create a \$25,000 scholarship for students who are working parents. This anonymous couple will also be including COD in their estate which amounts to an additional \$1M.

The Advancement and Stewardship committee has combined with the President's Circle committee. President's Circle committee going forward will be an ad hoc committee (not governed by the Brown Act) and will serve to create camaraderie and increase membership.

The newsletters for the President's Circle and Academic Angels will be combined and retitled, "The Roundup." It will cover all upcoming events for both memberships and will be published three times per year.

He gave an update on membership and talked about the need to reevaluate the lifetime membership designation. The committee is working with the staff to revamp the benefits of the various levels of memberships, which will take effect next year. Elena Moiseeva gave a presentation covering the new benefits.

### President Circle Membership Appreciation Events

The second President Circle Member Appreciation event will be held as scheduled on Sunday, March 3<sup>rd</sup>, 2024. This will be a "putters and pizza" event at Shadow Mountain Golf Club. Contracts for the use of the beautiful one-acre putting field and for the pizza catering have been completed and are in place. Pizza catering will be by Piero's PizzaVino. There will be four different pizzas, two salads, iced team, and soft drinks. There will be a hosted bar with bloody marys, mimosas, beer and wine. The head of the Shadow Mountain Putting Club, Barb Nelson, will attend as our guest and lead our members through the putting tournament. Participants will be in teams of four, scramble format, with best ball. Trophies for the winning team members are being made. There will also be drawings for great prizes. The club will provide putters, markers, balls, and score cards. Thus far we are more than halfway to our planned maximum of 60 people. We are projected to end up well under budget.

### Special Event for Screening of "Invisible Valley" film produced by Mary Pohlad

On February 5<sup>th</sup>, Jane Saltonstall and Rob Moon met with Michael Green, CEO/Executive Director of the Palm Springs Cultural Center, also known as the Camelot theatre. The theatre is part of the same square and adjoins the new COD campus site. It was a very good meeting. Michael is very excited about our hosting a screening at the theatre. We found that the main auditorium seats 490. We were also offered the use of the upstairs lounge for a VIP or reception prior to the screening. This space can easily accommodate 50 people, and if necessary, up to 100. There is a full bar there, and catering is available or can be brought in by an outside caterer. This space has a large balcony overlooking the construction site of the new Palm Springs COD Campus. The theatre can also accommodate chairs, lighting, and microphones for a post screening discussion of the film. We are currently planning our first committee meeting on this event, which is projected to be in November.

### Advancement and Stewardship/President Circle Meetings

The Foundation Advancement and Stewardship Committee Meeting, combined with the President Circle Committee, has not met since our January Foundation Board meeting. However, work is progressing well on the restructuring of the President Circle vis a vis the Advancement and Stewardship Committee. Also, staff is working on creating new informational material on the benefits of the different levels of President Circle membership. The new benefits will be in place for the 2024-2025 season.


