Discussion: Ed Gubman and Joan Lamb recommend modifying the bar charts to pie charts and including dollar amounts for better clarity. Joan also suggested listing cash under investment activities.

5.2 Review Proposed Budget Revisions

Presentation: Kirstien presented the proposed budget revision which included: 1) Insurance: increased by \$2,500, 2) Membership Dues: increased by \$175, 3) President's Fund: decreased by

\$9,872, total budget decreased by \$6,697.

Motion: A motion was made by Ed Gubman and seconded by Tom Minder to approve the proposed budget revisions. The motion carried.

5.3 Selection & Recommendation to Executive Committee for New Investment Managers Discussion: The Committee recommended Ferguson Wellman as the selected investment managers for the Foundation.

Action: The Foundation assured the Committee that Kirstien and Catherine would assist in overseeing a smooth transfer between investment firms.

Motion: A motion was made by Ed Gubman and seconded by Tom Minder to recommend Ferguson Wellman as the selected investment managers to the Executive Committee. The motion carried.
